

Tassie Devil 40th Anniversary - Win a Golden Lure

TERMS AND CONDITIONS

1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. **Entry is only open to Australian residents aged 16 years or over.**
